Essay Contest Official Rules:

- 2. Submission. Essays must be submitted via the IEW Website (www.global.emory.edu/iew) between 12:00 p.m. Eastern Standard Time (EST) on September 5th and 11:59 p.m. Eastern Standard Time (EST) on October 3, 2025 (the "Entry Period"). Submissions received after the close of the Entry Period will not be accepted unless the deadline is extended at the sole discretion of the Sponsor. For the purposes of this contest, the official timekeeping shall be based on Emory's local time zone (EST). Entrants submitting close to the deadline are solely responsible for ensuring timely submission and assume the risk of technical delays or other issues that may prevent successful entry.
- 2. **Evaluation Criteria**. Essays will be judged based on critical engagement with the essay themes, creativity, organization and structure, and adherence to the rules of the contest.
- 3. **Agreement with Rules**.
